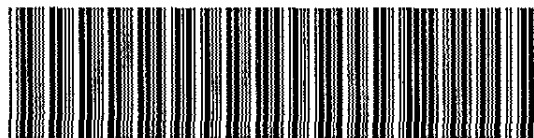

SECOND: The date of the filing of the Articles of Organization was February 12, 2003. The document number is L03000005359.


THIRD: Article 1 of the Articles of Organization of the Limited Liability Company is hereby amended to read as follows:

1. "The name of this Limited Liability Company is Magi Management Company, LLC (hereinafter the "Limited Liability Company")."


