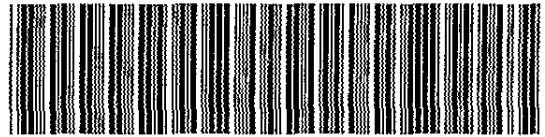


1. Name. The name of the limited liability company is The Doug Out Sportswear, LLC.


