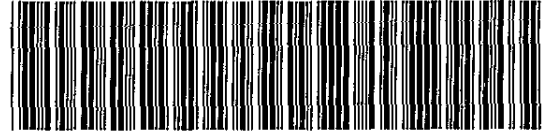

**ARTICLES OF ORGANIZATION  
OF  
TAMPA BAY IMAGING MANAGEMENT, LLC**

**ARTICLE I - Name**

The name of the Limited Liability Company is TAMPA BAY IMAGING MANAGEMENT, LLC (the "Company").

**ARTICLE II - Address**

The mailing address and street address of the principal office of the Company is Dept. of Radiology, UCH, 3100 East Fletcher Ave., Tampa, Florida 33613.

**ARTICLE III - Term**

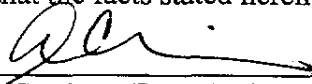
