Admission of New Members

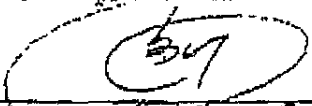

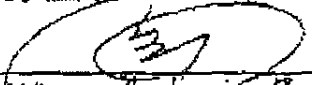

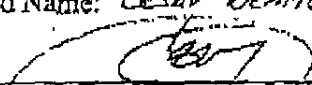
