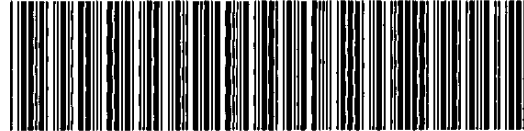

3. Delete Article IV of the Articles of Organization of the Company and substitute in lieu thereof, the following:


ARTICLE IV
