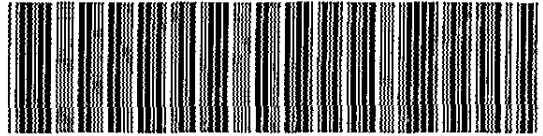

ARTICLES OF ORGANIZATION  
FOR  
M.R. INTERNATIONAL GROUP, LLC

ARTICLE I - Name

The name of this limited liability company shall be M.R. INTERNATIONAL GROUP, LLC.

ARTICLE II - Duration

The limited liability company shall have a perpetual existence.

ARTICLE III - Purpose and Powers

Except as restricted by these Articles of Organization, this limited liability company is organized for operating a taxi service for members of the general public as well as each and every legal and lawful purpose for which a limited liability company may be organized pursuant to the Florida Limited Liability Company Act.

Except as restricted by these Articles of Organization, this limited liability company shall have and may exercise all powers and rights which a limited liability company may exercise under Florida law or the laws of the United States of America.

ARTICLE IV - Principal Office

The mailing address and the street address of this limited liability company shall be: 3700 Fifth Avenue North, St. Petersburg, FL 33713.

ARTICLE V - Initial Registered Agent and Office

ARTICLE VI - Additional Members

This limited liability company may admit additional members subject to approval by unanimous vote of the existing members.

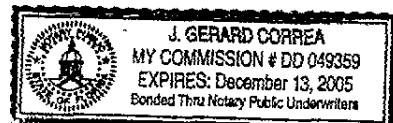




