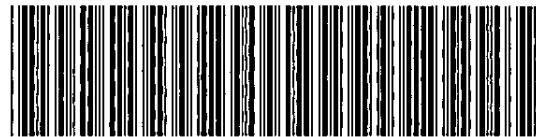

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of **SIERRA PROPERTIES I, LLC**, a Florida limited liability company (the "Company"), pursuant to the Florida Limited Liability Company Act, as amended, *Florida Statutes* § 608.411:

1. Name of Company. The name of the Company is **SIERRA PROPERTIES I, LLC**.
2. Date of Filing of Articles of Organization. The Company filed its Articles of Organization with the Florida Department of State with an effective date of February 21, 2003 (the "Articles").
3. Amendment to Articles of Organization. Paragraph 7 of the Company's Articles is amended by deleting the current text of Paragraph 7 in its entirety and substituting the following in lieu thereof, to be effective as of ^{FEBRUARY 15} ~~December~~ ____, 2008:

"7. Management of the Company. The management of the Company shall be vested in the managers of the Company."
