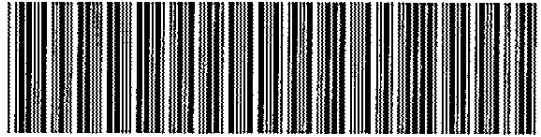

**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be **ZIP SERVICES, LLC.**, ("Company").

ARTICLE III – EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE IV – DURATION

Subject to the provisions of Article X, the Company's existence shall terminate no later than 99 years from its date of commencement, unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE V – PURPOSES AND POWERS

The general purpose for which the company is organized is to engage in the offering of business products and services for the small business market and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE VI – REGISTERED OFFICE AND REGISTERED AGENT

The initial address of the registered office of this Company is 10046 NW 41st ST, Miami, Florida 33178. The name of the registered agent is Fernando Azpurua, whose address is the same as the registered office.

ARTICLE VII – MANAGMENT


