The Articles of Organization following are adopted for the purpose of organizing a Company under the Florida Limited Liability Company, Act, Chapter 608, Florida Statutes.

ARTICLE I

Name and Address of Company

The name of the limited liability company (hereinafter referred to as the "Company") is MALLOY'S BIG CONTAINER PLANTS, LLC. The Company's street address is U. S. 19 North, Monticello, Florida 32344; it's mailing address is P.O. Box 244, Monticello, Florida 32345.

ARTICLE II

Commencement, Duration and Power of Company
