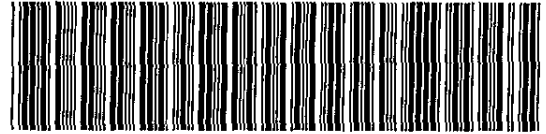

**ARTICLE I - NAME**

The name of the Limited Liability Company is Merrill Pines Development Company, LLC (the "Company").
