ARTICLES OF ORGANIZATION

OF

BUY, SELL, OR HOLD, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 1608, Flere of makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be BUY, SELL, OR HOLD, LLC, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 520 Crown Oak Centre, Longwood, Florida 32750 and the mailing address shall be the same.
