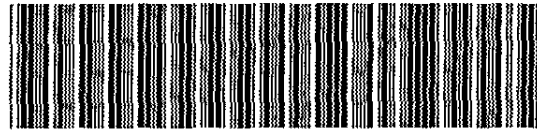



INDEMNIFICATION




