

**ARTICLES OF ORGANIZATION OF
S&S INVESTMENT, L.L.C.**

Article I

The name of the limited liability company ("Company") is S&S INVESTMENT, L.L.C.

Article II

The mailing and street address of the Company's principal office is 788 Kangaroo Court, Deltona, Florida 32738. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.


Article VII




