ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION
OF
CYGRAM, LLC

The undersigned being the Authorized Representative of the Members of CYGRAM, LLC, a Florida limited liability company (the "Company"), in accordance with the provisions of Chapter 605, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is CYGRAM, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State on February 20, 2003, as amended by Articles of Amendment to Organization filed with the Florida Department of State filed on March 18, 2013 (the "Articles of Organization").
3. Article IV of the Company's Articles of Organization, is deleted in its entirety and the following is substituted therefore:

ARTICLE IV

"The Limited Liability Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. The authority and duties of the Manager(s) shall be as set forth in the Operating Agreement of the Limited Liability Company. The names and address of the current Managers are Panayiotis Vasilouides and Helen Vasilouides, 5210 Webb Road, Tampa, Florida 33615."

4. These Articles of Amendment to Articles of Organization shall be effective upon filing with the Florida Department of State.
5. These Articles of Amendment have been approved by unanimous Written Action of the Members dated April 21st, 2015, which vote is sufficient for approval.
6. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.

The execution of these Articles of Amendment of the Articles of Organization by the undersigned constitutes an affirmation under the penalties of perjury that the facts stated herein are true and correct.
