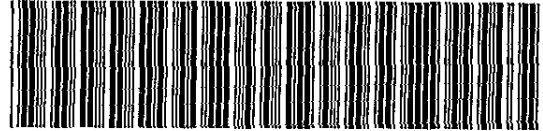

ARTICLE I
Name


