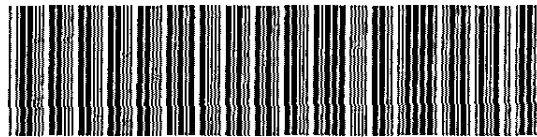

"ARTICLE IV - MANAGEMENT:

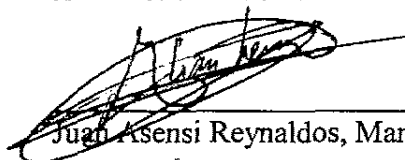
The Limited Liability company is to be managed by the member and the name and address of the sole member is:
