**ARTICLES OF ORGANIZATION
OF
SALEM M. HABAL, M.D., P.L.
A FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY**

The undersigned, in forming a Florida Professional Limited Liability Company ("Company") under the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Organization for such Company:

ARTICLE I

NAME

The name of the Company is **Salem M. Habal, M.D., P.L.**

ARTICLE II

ADDRESS

The mailing address and the street address of the principal office of the Company is 1940 N.E. 47th Street, Suite 1, Fort Lauderdale, Florida, 33308.

ARTICLE III

PURPOSE
