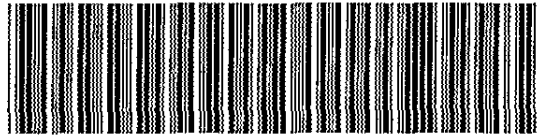



**ARTICLE I – NAME**


The name of this limited liability company is Sunny Side Leasing & Management, LLC (the "Company").


