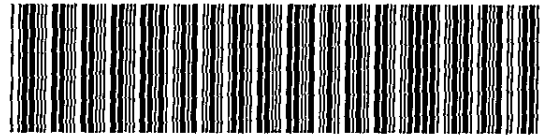

members and the terms and conditions of the admissions shall be:


No additional members shall be admitted to the company except


