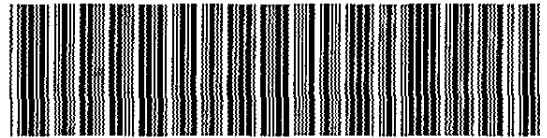

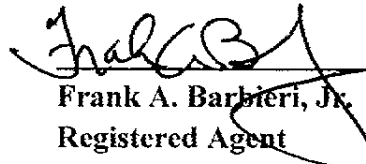

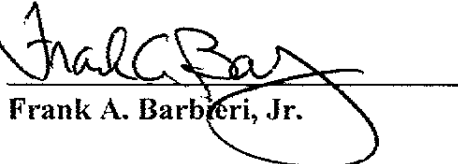

5. **Management.** The Professional Liability Company is to be managed by one member or more members and is, therefore, a member - managed company.

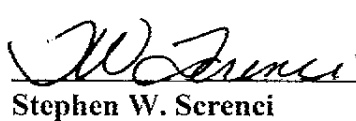
