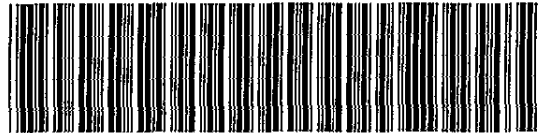

**ARTICLES OF ORGANIZATION
GROSU INVESTMENTS
L. L.C.**

The undersigned adopt the following Articles of Organization for the purpose of becoming a limited liability company under the Florida Limited Liability Company Act:

**ARTICLE I
Name**

The name of the limited liability company, referred to in these Articles as "Company" is GROSU INVESTMENTS, L.L.C.

**ARTICLE II
Duration**

The company shall dissolve on December 31, 2033.

ARTICLE VIII
Admission of New Members

Additional members may be admitted only on the unanimous written consent of existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted. Provided, however, the original two members may transfer all or part of his or her interest to an immediate member of his or her family and his or her family members shall automatically be admitted as a member.

ARTICLE IX
Remaining Members

The remaining members of the company may continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company.

ARTICLE X
Additional Provisions

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the managers listed in Article VII.

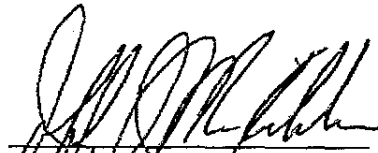
