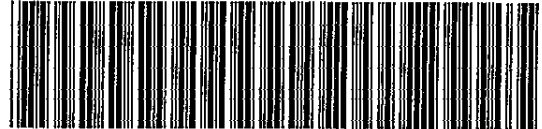

**ARTICLES OF ORGANIZATION
SHAHAN TRUCKING, LLC**

ARTICLE I. - NAME
