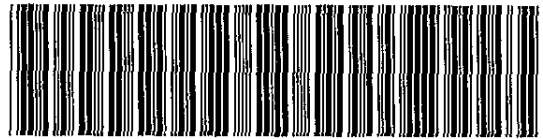

**ARTICLES OF ORGANIZATION
OF
HIDDEN CREEK DEVELOPMENT, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I
NAME

The name of the limited liability company shall be HIDDEN CREEK DEVELOPMENT, LLC ("COMPANY").

ARTICLE II


ARTICLE V


