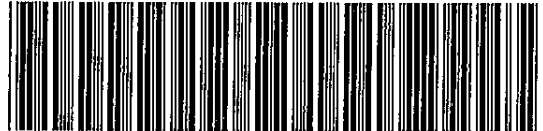


**ARTICLE II****INITIAL REGISTERED OFFICE AND REGISTERED AGENT**


