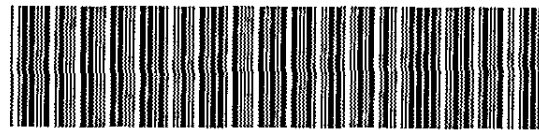

ARTICLES OF ORGANIZATION OF PATRICK H. WILLIS, PL

Article I- The name of the Professional Limited Liability Company is the following:
Patrick H. Willis, PL.

Article II- Purpose of the Professional Limited Liability Company and the scope of its powers.

Patrick H. Willis, PL is organized for the purpose of carrying on the practice of law, a professional service. It shall be the aspiration and practice of Patrick H. Willis, PL to represent the interests of its clients in both a highly ethical and zealous manner. Patrick H. Willis, PL is intended to have the power to engage in any lawful purpose consistent with its status as a Professional Limited Liability Company, as provided in Chapter 621, Florida Statutes. Patrick H. Willis, PL is also intended to have the full range of powers of a Limited Liability Company as provided in Section 608.404, Florida Statutes.



Article V- Management of Patrick H. Willis, PL

It is the intent of Patrick H. Willis, PL to adopt a management style that mirrors that of a partnership. Accordingly, management responsibilities and voting rights will be vested in its members.

Article VI- Special voting rights of founding members

Patrick H. Willis, PL's founding member is Patrick H. Willis. This founding member shall have a special veto power over any decisions of the company. This provision should not be construed as inconsistent with any provision in the operating agreement that provides for a system of management by majority vote. Rather, the intended effect is to require that the majority vote must include the vote of the founding member.


Article VII- Issues not addressed by Articles of Organization

Any Issues not addressed by these articles of organization shall be controlled by the operating agreement of Patrick H. Willis, PL. These issues shall include, but are not limited to the following: voting rights, voting classes, dissolution, the sharing of profits and losses, contributions, distributions, withdrawal of members, addition of new members, effect of bankruptcy on membership status, indemnification rights, liability upon wrongful distributions, assignment of interests and rights of dissenting members.

Article VIII- Effective date of Patrick H. Willis, PL

The effective Date shall be February 12, 2003. This date is within five days prior to the filing of the original Articles of Organization.

The Execution of these Articles of Organization constitutes an affirmation under the penalties of perjury that the facts stated therein are true.
