FIRST AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
K&L ENTERPRISES, LLC

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of K&L Enterprises, LLC, originally filed on June 30, 2021, are amended and restated in their entirety to read as follow:

ARTICLE I - NAME

The name of the limited liability company is Green Swan Investments, LLC (the "Company").

ARTICLE II - INCORPORATION

The Company's Articles of Organization were filed on February 25, 2003. The Company was assigned document number L03000006894.

ARTICLE III - ADDRESS

The street and mailing address of the Company's principal office are:

ARTICLE IV - PURPOSE

The Company is organized for the purpose of performing all lawful business permitted under the laws of the United States and of the State of Florida.

ARTICLE V - REGISTERED OFFICE AND AGENT

The Company (i) designates One Independent Drive, Suite 1200, Jacksonville, Florida 32202 as the street address of the Company's registered office, and (ii) names Contega Business Services, LLC as the Company's registered agent at that address to accept service of process within the State of Florida.

ARTICLE VI - MANAGEMENT AND AUTHORITY

The Company shall be a manager-managed company. Pursuant to Section 605.04074, Florida Statutes, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.

The following individuals shall serve as managers of the Company until their respective successors are appointed or elected and qualified pursuant to the applicable provisions contained in the Company's Operating Agreement, or until the earlier of such respective managers' death, dissolution, removal or resignation:



ARTICLE VI - INDEMNIFICATION

The Company shall indemnify any person who is or was a party to any proceeding by reason of the fact that such person is or was a manager, member or officer of the Company or its subsidiaries, to the fullest extent not prohibited by law, for actions taken in the capacity of such person as a manager, member or officer of the Company or its subsidiaries. To the fullest extent not prohibited by law, the Company shall advance reasonable indemnification expenses (including attorneys' fees and costs) for actions taken in the capacity of such person as a manager, member or officer within twenty (20) days after receipt by the Company of (a) a written statement requesting such advance, (b) evidence of the expenses incurred, and (c) a written statement by or on behalf of such person agreeing to repay the advanced expenses if it is ultimately determined that such person is not entitled to be indemnified against such expenses.

The undersigned authorized representative, for the purpose of amending and restating the Company's Articles of Organization under the laws of the State of Florida, has executed these First Amended and Restated Articles of Organization.


