**ARTICLES OF ORGANIZATION
OF
SANDY'S SIGNATURES HOMES, LLC**

ARTICLE I

Name and Duration

The name of this Limited Liability Company is Sandy's Signatures Homes, LLC (hereinafter referred to as the "Company"). The duration of the Company shall be perpetual.

ARTICLE II

Principal Office

ARTICLE III

Management


The Company shall be Member managed.

REGISTERED AGENT CERTIFICATE


