**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION
OF
SANDY'S SIGNATURES HOMES, LLC**

Pursuant to the requirements of Section 608.411, Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment to the Articles of Organization of be Sandy's Signatures Homes, LLC (the "Company"), which Company was organized under the laws of the State of Florida on February 25, 2003:

1. The sole member of the Company has approved a change in the name of the Company. Therefore, Article I of the Company's Articles of Organization shall be deleted in its entirety and, in lieu thereof, there shall be substituted the following:

"ARTICLE I"

Name and Duration
