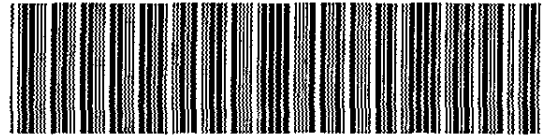

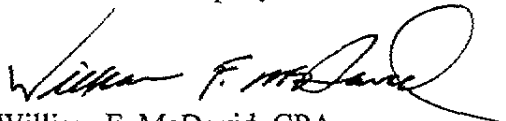

**ARTICLES OF ORGANIZATION

**ARTICLE I - NAME**

The name of the limited liability Company (hereinafter referred to as "Company") is: **441 SELF STORAGE, LLC.**

**ARTICLE II - EXISTENCE**

The Company shall have perpetual existence commencing on the date these Articles of Organization are filed with the Florida Department of State.

**ARTICLE III - LOCATION**

The street and mailing address of the principal office of the Company is **16026 Northeast 2<sup>nd</sup> Street, Gainesville, Florida, 32609.**

**ARTICLE IV - PURPOSES AND POWERS**

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

**ARTICLE V - REGISTERED OFFICE AND AGENT**

The street address in the State of Florida of the initial registered office of the Company is **16026 Northeast 2<sup>nd</sup> Street, Gainesville, Florida, 32609**, and the name of its initial registered agent at such address is **David C. Robinson.**

**ARTICLE VI - CAPITAL CONTRIBUTIONS**

The members of the Company shall each contribute to the capital of the Company the sum of **\$1,000.00.**

## ARTICLE VII - ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the Company only upon the unanimous consent of all the members.

## ARTICLE VIII - ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the Regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

## ARTICLE IX - TERMINATION OF EXISTENCE

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there is at least one remaining member.

## ARTICLE X - MANAGEMENT

The Company shall be managed by one or more managers as set forth in the Regulations. The initial manager shall serve until the first meeting of the members or until his successor is elected and qualifies. The initial manager and his address is DAVID C. ROBINSON, 16026 Northwest 2<sup>nd</sup> Street, Gainesville, Florida, 32609.
