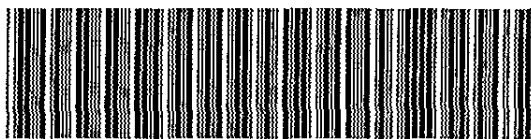

The mailing address and street address of the principal office of the Company is 1100 East Tennessee Street, Tallahassee, Florida 32308.


