### ARTICLES OF ORGANIZATION MB FLAGLER PROPERTY, LLC

#### **ARTICLE I - Name**

AND THE SERVICE The name of the Limited Liability Company is MB FLAGLER PROPERTY, LLC (the"Company").

#### ARTICLE II - Address
