

ARTICLES OF ORGANIZATION

OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Company Act, Florida Statutes Chapter 608, hereby make, Acknowledge, and file the following Articles of Organization.

ARTICLE 1 - NAME

ARTICLE 3 - EFFECTIVE DATE


These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.
