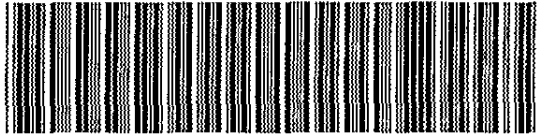

**ARTICLES OF ORGANIZATION OF SENIOR RESOURCE
SERVICES, LLC,
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, being the member, is authorized to execute and file these Articles, and hereby certifies that:

ARTICLE I - Name:

The name of the limited liability company is SENIOR RESOURCE SERVICES, LLC.

ARTICLE II - Address And Registered Agent:


