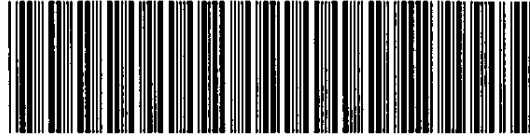

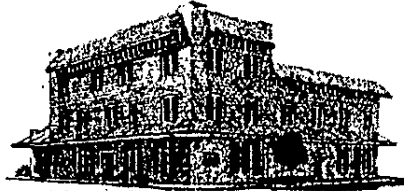

- A. The name of the Company is SUGAR MILL DEVELOPERS, LLC.
