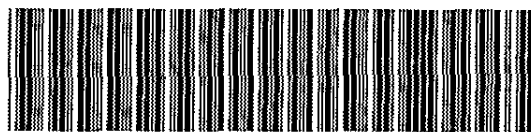

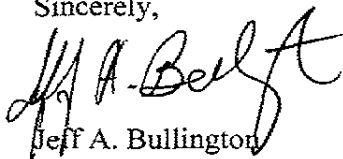

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act (the "LLC Act"), does hereby execute the following Articles of Organization:

**ARTICLE I - Name:** The name of the limited liability company is TBM, L.L.C. (the "Company").

**ARTICLE II - Address:** The mailing address and street address of the principal office of the Company is 12632 Victoria Place #116, Orlando, FL 32828.

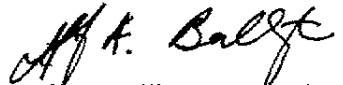
**ARTICLE III - Registered Agent, Registered Office, & Registered Agent's Signature:**  
The name and Florida street address of the registered agent of the Company in the State of Florida are Jeff A. Bullington, 12632 Victoria Place #116, Orlando, FL 32828. Having been named as registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, F.S.

**ARTICLE IV - Management:**
