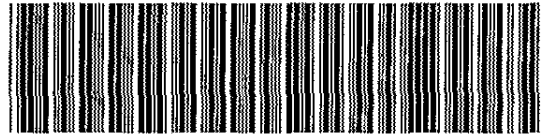

ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I-Name and Principal Place of Business

The name of the limited liability company shall be **DuPuis & Jacobs at Edgewater, LLC** (hereinafter the "Company"). The principal place of business and mailing address of the Company shall be 3432 Tamarind Drive, Edgewater, Florida 32141.

ARTICLE II-Duration

The Company shall commence its existence on the date these Articles of Organization are filed with and accepted by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization and the Regulations of the Company.

ARTICLE III-Purposes and Powers

The general purpose for which the Company is organized is to acquire, own, and develop real estate; however it shall be able to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE IV-Registered Office and Agent

The name and street address of the registered agent of the Company in the State of Florida is Joseph W. Jacobs, 1545 Raymond Diehl Road, Suite 300, Tallahassee, Florida 32308.

ARTICLE V-Management

The Company is to be managed by one or more managers and is therefore, a manager-managed company. The initial managers shall be Michael A. DuPuis and Christopher W. Jacobs.

ARTICLE VI-Regulations

The power to adopt, alter, amend, or repeal the Regulations of the Company is vested in the members of the Company as provided in the Regulations.
