**ARTICLES OF ORGANIZATION

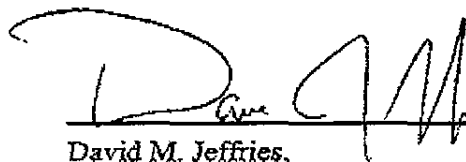
ARTICLE IIIManagement of the Company

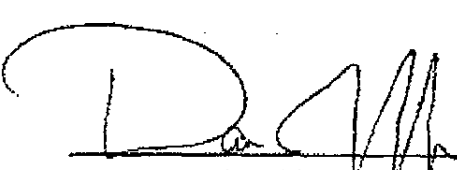
