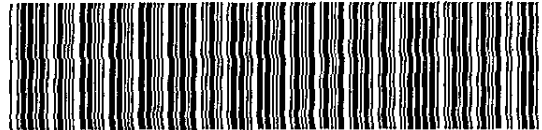

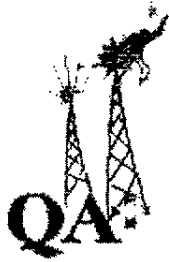

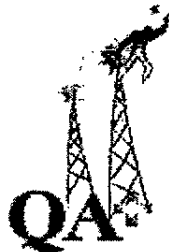
Regarding the future work of current contract we currently have. A letter will be sent regarding the dissolution of QA Plus.


