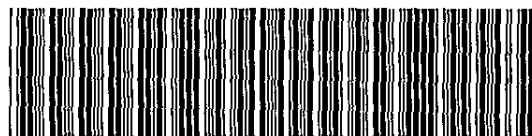



ARTICLE I - Name




