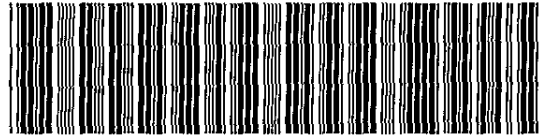



LIMITED POWER OF ATTORNEY




