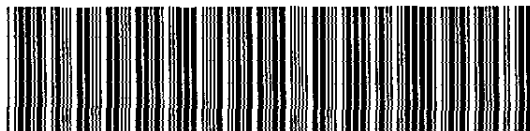

### CONTINUATION OF BUSINESS


