ARTICLES OF ORGANIZATION

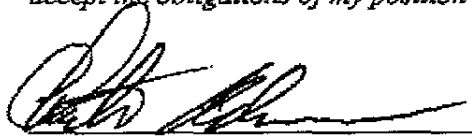
