## ARTICLES OF ORGANIZATION OF ARMSDALE LAND, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

#### ARTICLE I: Name

The name of the limited liability company is ARMSDALE LAND, L.L.C. (the Company).

#### ARTICLE II: Address

#### ARTICLE VII: Admission and Withdrawal of Members

No additional members shall be admitted to the Company except with the imanimous written consent of the members of the Company. The events which shall cause voluntary of involuntary withdrawal of a member shall be only as specified in the Operating Agreement.

#### ARTICLE VIII: Termination of Existence

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.

#### ARTICLE IX: Articles and Operating Agreement

The Operating Agreement shall be adopted by a majority in interest of the members. Except as otherwise provided herein and in the Operating Agreement, the Operating Agreement and these Articles of Organization may be amended from time to time with the written consent of a majority in interest of the members, provided, however, that Articles VII and VIII of these Articles of Organization may be amended only upon the unanimous consent of all the members.
