AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF INTREPID LAW GROUP, P.L.

Pursuant to Section 608.411, Florida Statutes, the Articles of Organization of Internal Law, Group, P.L., originally filed on March 6, 2003, are amended and restated in their entirety to read at follows:

ARTICLE I - NAME

At any time there are no members, the Company shall not be dissolved and shall not be required to be wound up if, within one (1) year after the occurrence of the event that terminated the continued membership of the last remaining member, the personal representative or other legal representative of the last remaining member agrees in writing to continue the Company and agrees to the admission of the personal representative or other legal representative of such member or its nominee or designee to the Company as a member, effective as of the occurrence of the event that terminated the continued membership of the last remaining member.
