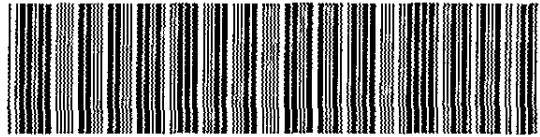


Admission of Additional Members


