**ARTICLES OF ORGANIZATION
OF
RCBI, LLC**

The undersigned, for the purpose of forming a limited liability company for profit under the laws of Florida, adopts the following Articles of Organization:

**Article I
Name**

Section 1.1. Name. The name of this limited liability company shall be RCBI, LLC.

**Article II
Principal Office and Mailing Address**

Section 2.1. Principal Office and Mailing Address. The principal office and mailing address of this limited liability company shall be 2743 Rachael Street, Fernandina Beach, FL 32034.

**Article III


Article IX


