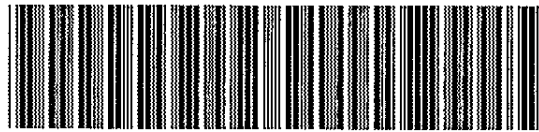

ARTICLE I - Name:

The Limited Liability Company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Limited Liability Company, unless the business of the Limited Liability Company is continued by majority vote of all the remaining members.

The Company shall have perpetual duration.

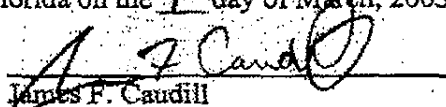
ARTICLE VIII - Organizer

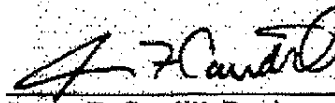
CERTIFICATE OF DESIGNATION OF REGISTERED AGENT
