ARTICLES OF ORGANIZATION OF DOUBLE R HOLDINGS, LLC (A Florida Limited Liability Company)

ARTICLE I

The name of the Limited Liability Company is Double R Holdings, LLC.

ARTICLE II ADDRESS

ARTICLE III DURATION
