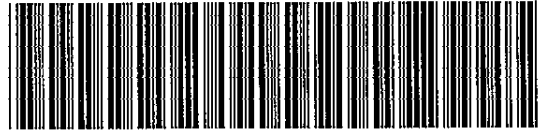




LIMITED POWER OF ATTORNEY
