



# ARTICLES OF ORGANIZATION

OF

#### MRM, LLC.

Pursuant to Section 608.407, Florida Statutes, these Articles of Organization for a limited liability company provide that:

### **ARTICLE I - NAME**

The name of the limited liability company is MRM, LLC.

#### **ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the limited liability company is 301 W. Olympia Avenue, Punta Gorda, Florida 33950.
